June 16 due: Walk Friendly Communities Announce Call for Applications

June 30 due: Environmental Enhancement and Mitigation Grants Available

Up to \$7 million dollars is available for local, state, and federal government agencies, as well as non-profit organizations, for projects that mitigate the environmental impacts caused by new or modified public transportation facilities. Eligible projects include urban forestry, resource lands, and mitigation projects that produce multiple benefits that reduce greenhouse gas emissions, increase water use efficiency, reduce risks from climate change impacts, and demonstrate collaboration with local, state, and community entities. The Monday Campaigns Innovation Fund

The Monday Campaigns is a non-profit public health initiative associated with Johns Hopkins, Columbia, and Syracuse Universities. Their goal is to create a movement of individuals and organizations who join together every Monday to commit themselves to health. The Monday Campaigns is now offering small operational grants of \$5,000 to \$10,000 for Monday-focused programming. The fund is intended to offer a "rapid response" to promising proposals, and grants will be evaluated on a rolling basis. RESEARCH AND RESOURCES

2014 United States Report Card on Physical Activity for Children and Youth

The National Physical Activity Plan Alliance and the American College of Sports Medicine have released the nation's first <u>United States Report Card on Physical Activity for Children and Youth</u>. The report provides a comprehensive evaluation of physical activity levels and indicators influencing physical activity among children and youth. Physical activity was graded across ten indicators, with one indicator illustrating that less than half of children and youth in the United States are meeting physical activity standards. 2014 Bicycle and Pedestrian Benchmark Report

The Alliance for Biking and Walking has released the <u>Bicycling and Walking in the United States</u>: <u>2014</u> <u>Benchmarking Report</u>, a compendium of data on bicycling and walking in all 50 states, the 52 largest cities in the United States, and a select number of midsized cities. The Alliance for Biking and Walking produces the Benchmarking Report every two years in partnership with the Centers for Disease Control and Prevention (CDC) Healthy Community Design Initiative. The report comprehensively examines bicycling and walking transportation across the United States and how these trends relate to public health, safety, and social and economic wellbeing. In the executive summary of the report, the 50 states are ranked for a number of factors, for which California ranks 19th highest for commuter walking and bicycling levels, 30th highest for per capita spending on pedestrian/bicycle projects, 33rd lowest in pedestrian/bicyclist fatality rates, and 5th highest in getting recommended physical activity.

A Comparative Analysis of Pedestrian and Bicyclist Safety around University Campuses

In March 2014, the University of California Transportation Center published a report entitled "A Comparative Analysis of Pedestrian and Bicyclist Safety Around University Campuses." Large college campuses generate considerable volumes of traffic in a variety of modes, and in greater numbers, than found in most United States settings. The college campus setting presents a unique study opportunity, as well as a significant potential for conflicts between motorized and non-motorized users of the transportation system, as most campuses are by mixed-use environments (e.g., retail, restaurant, entertainment, and high-density residential facilities such as apartments and dorms). This study examines the campus cores and peripheries of the University of California, Berkeley, the University of California, Los Angeles, and California State University, Sacramento, in order to compare safety risks for pedestrians and bicyclists among the three locations. Getting There Safely: A Pedestrian Safety Video from the National Highway Traffic Safety Administration

The National Highway Traffic Safety Administration (NHTSA) updated the Willy Whistle "Walking With Your Eyes" pedestrian safety video for youth aged seven to ten. This video, suitable for up to age 12, briefly reviews the safety skills covered in the "Stop and Look with Willy Whistle" video for younger children, and includes more advanced pedestrian safety skills and concepts such as safety near roads with high traffic volumes, crossing controlled and signalized intersections, and visual screens and safety in parking lots. The National Partnership has released a <u>fact sheet</u> with the results of recent research on the greenhouse gas emissions reduction possibilities of Active Transportation.

Human Factors Assessment of Pedestrian Roadway Crossing Behavior

In January 2014, the Federal Highway Administration's (FHWA) published the "<u>Human Factors</u> <u>Assessment of Pedestrian Roadway Crossing Behavior</u>" report, which highlights that while drivers are more likely to yield to pedestrians in the marked crosswalk, pedestrians and vehicles are equally as likely to yield to one another outside the marked crosswalk and that pedestrians cross when perceived control of the crossing is greatest. The report describes different measures that can impact this perceived control and presents a model to predict pedestrian crossing location.

Prevention Status Reports Update

The CDC publishes Prevention Status Reports (PSRs)—for all 50 states and the District of Columbia—that highlight the status of public health policies and practices designed to prevent or reduce ten important public health problems. There are two additional reports available on the 2013 Prevention Status Reports (PSRs) website:

School Transportation-Related Crashes 2003-2012—Traffic Safety Fact Sheet

NHTSA recently released a fact sheet entitled "School Transportation-Related Crashes." A school-transportation-related crash is a crash that involves, either directly or indirectly, a school bus body vehicle, or a non-school bus functioning as a school bus, transporting children to or from school or school-related activities. According to the data, since 2003 there were 348,253 fatal motor vehicle traffic crashes. Of those, 1,222 (0.35 percent) were classified as school-transportation-related. Since 2003, there have been 1,353 people killed in school-transportation-related crashes—an average of 135 fatalities per year. Occupants of school transportation vehicles accounted for 8 percent of the fatalities, and non-occupants (pedestrians, bicyclists, etc.) accounted for 21 percent of the fatalities. Statewide Transportation Planning for Healthy Communities—FHWA White Paper

In April 2014, the FHWA Office of Planning, in partnership with the United States Department of Transportation Volpe National Transportation Systems Center, prepared a white paper entitled "Statewide Transportation Planning for Healthy Communities." The white paper, the second in a series from FHWA, presents insights and a flexible framework for State Departments of Transportation that choose to integrate public health considerations into their transportation planning and decision making.

Traffic Safety Trends—State Legislative Action 2013

In February 2014, the National Conference of State Legislatures published the <u>Traffic Safety Trends State Legislative Action 2013 report</u>. The "Bicycle and Pedestrian Safety" section of the report highlights that pedestrian deaths increased 6.4 percent nationally from 2011 to 2012 and bicyclist deaths increased 6.5 percent. The report states that common legislative strategies to enhance traffic safety for pedestrians and bicyclists include vulnerable user laws, complete streets, safe bicycling passing laws, and yield to pedestrian laws.
